

## HomeTown Credit Union Member Appreciation Giveaway Official Rules – September 2022

**Eligibility:** The HomeTown Credit Union Member Appreciation Days Facebook Contest (the “Contest”) is open to all members. Employees and immediate family members of employees are not eligible to win. Only one entry per member will be accepted. The Contest is subject to all applicable federal, state, and local laws and regulations. The Contest is void where prohibited by law.

**Timing:** The Contest begins on Wednesday, August 31, 2022 at 7:00pm CST and ends Friday, September 2, 2022 at 12:00pm CST.

**How to Enter:** To enter, members must Like, Comment on, or Share the giveaway Facebook post on the HomeTown Credit Union Facebook page. Any comments written must be positive in nature with no rude, vulgar, or offensive language accepted.

**Terms of Use:** By entering and submitting to the Contest, all entrants grant HomeTown Credit Union the right to publish their name as a winner in their branches, on HomeTownCU.coop, on HomeTown Credit Union social media sites, and any other manner at any time.

**Winner Determination:** All eligible entries will be put together on Friday, September 2 at 12:00pm CST, and a single winner will be selected at random. The winner will then be notified. The prize is guaranteed to be awarded, assuming a sufficient number of entries are received. All entries by members are subject to verification by HomeTown Credit Union, whose decisions are final and binding.

**General:** If for any reason this Contest is not capable of running as planned, or if this Contest or any website associated therewith (or any portion thereof) becomes corrupted or does not allow the proper administration of the Contest and processing of entries in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by entrants, fraud, technical failure, or any other causes, in the HomeTown Credit Union’s sole opinion, corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Contest, HomeTown Credit Union reserves the right to disqualify any individual implicated in such action and/or to cancel, terminate, modify or suspend this Contest or any portion thereof. In the event HomeTown Credit Union is prevented from continuing with the Contest by any event beyond its control, including but not limited to fire, flood, earthquake, explosion, labor dispute or strike, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state, or local government law, order, or regulation, or order of any court or other cause not within HomeTown Credit Union’s control, they shall have the right to modify, suspend, extend or terminate the Contest. If a cancellation, termination, modification, or suspension occurs, notification will be posted on HomeTownCU.coop. If cancelled, HomeTown Credit Union reserves the right to award prize as outlined herein with respect to all eligible entries received at the time of the termination. HomeTown Credit Union reserves the right to disqualify entrants who violate these Official Rules or interfere with this Contest in any manner. Any attempt by an entrant or any other individual to deliberately damage any website or undermine the legitimate operation of the Contest is a violation of criminal and/or civil laws and should such an attempt be made, HomeTown Credit Union reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. HomeTown Credit Union’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

**Disputes:** All disputes connected with this Contest shall be resolved individually, without resort to any form of class action.
