

HomeTown Credit Union Coloring Contest Official Rules – April 2023

Eligibility: The HomeTown Credit Union Coloring Contest (the “Contest”) is open to all youth members, age 18 and younger. Immediate family members of employees are not eligible to win. Only one entry per member will be accepted. The Contest is subject to all applicable federal, state, and local laws and regulations. The Contest is void where prohibited by law.

Timing: The Contest begins on April 1, 2023, at 8:30am CST and ends April 28 at 3:00pm CST.

How to Enter: To enter, download the coloring page from the HomeTown Credit Union website, print it, have the youth member color it, and then submit it one of two ways: (1) Deliver it to one of the four HomeTown Credit Union branches or (2) scan it and email it to Marketing@HomeTownCU.coop with the subject *Coloring Contest*. Ensure the youth member’s name, age, and a contact phone number are listed on the coloring sheet so they can be notified should they win. Evidence of submitting an entry does not constitute evidence that HomeTown Credit Union received the entry.

Terms of Use: By entering and submitting to the Contest, all entrants grant HomeTown Credit Union the right to publish the entries in their branches, on HomeTownCU.coop, on HomeTown Credit Union social media sites, and any other manner at any time.

Winner Determination: All eligible entries will be judged based on creativity and chosen by HomeTown Credit Union. There will be a grand prize winner in the 11 & under category as well as the 12–18-year-old category. There will also be second prize winners in both categories for a total of 4 prize winners. Prizes will be HomeTown Credit Union swag boxes valued at approximately \$30 and \$15 each respectively. Prize winners are responsible for picking up their prize at a HomeTown Credit Union branch. Each prize is guaranteed to be awarded, assuming a sufficient number of entries are received. All entries and potential prize winners are subject to verification by HomeTown Credit Union, whose decisions are final and binding. A winners list will be posted on the HomeTown Credit Union website once chosen.

General: If for any reason this Contest is not capable of running as planned, or if this Contest or any website associated therewith (or any portion thereof) becomes corrupted or does not allow the proper administration of the Contest and processing of entries in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by entrants, fraud, technical failure, or any other causes, in the HomeTown Credit Union’s sole opinion, corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Contest, HomeTown Credit Union reserves the right to disqualify any individual implicated in such action and/or to cancel, terminate, modify or suspend this Contest or any portion thereof. In the event HomeTown Credit Union is prevented from continuing with the Contest by any event beyond its control, including but not limited to fire, flood, earthquake, explosion, labor dispute or strike, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state, or local government law, order, or regulation, or order of any court or other cause not within HomeTown Credit Union’s control, they shall have the right to modify, suspend, extend or terminate the Contest. If a cancellation, termination, modification, or suspension occurs, notification will be posted on HomeTownCU.coop. If cancelled, HomeTown Credit Union reserves the right to award prizes as outlined herein with respect to all eligible entries received at the time of the termination. HomeTown Credit Union reserves the right to disqualify entrants who violate these Official Rules or interfere with this Contest in any manner. Any attempt by an entrant or any other individual to deliberately damage any website or undermine the legitimate operation of the Contest is a violation of criminal and/or civil laws and should such an attempt be made, HomeTown Credit Union reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. HomeTown Credit Union’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Disputes: All disputes connected with this Contest shall be resolved individually, without resort to any form of class action.
